RE: State regulations and local COVID-19 mitigation requirements for

Nondiagnostic General Health Assessments (NGHA) Program in City &

County of San Francisco

Non-Diagnostic General Health Assessment (NGHA) programs are regulated by local public health departments following the California Business and Professional Code, Chapter 195, Sections 1244, 1244.1, 1244.3 and 1233.4. The San Francisco Public Health Laboratory provides oversight for all NGHA testing events held in the City & County of San Francisco, California.

NGHA vendor/industry applicants should be aware of the laws and regulations that apply to non-diagnostic testing in the State of California in addition to the regulations for the City & County of San Francisco under the emergency COVID-19 health order.

To register a program, the State of California has the following requirements:

- Must have a Clinical Laboratory Improvement Amendments (CLIA) Certificate of Waiver
- Committee must include a California Physician/Surgeon and a Clinical Laboratory
 Scientist who oversees testing personnel and quality control on its roster
- The Laboratory Director must be designated on the CLIA certificate

Only **outdoor** events are permitted by the City & County of San Francisco. **NGHA vendor/industry applicants are required to comply with and implement the following when planning events in San Francisco**:

- Appendix A: Social Distancing Protocol (revised 3/2/2021) as outlined in <u>Health</u>
 Order C19-07t;
- Health & Safety Plan Checklist under the Farmers Market Directive; and,
- the outdoor <u>Health & Safety Plan</u> Checklist under the <u>Personal Services Directive</u>, if vendor/event staff must touch or interact within 6' of attendees.

Summary of Process for NGHA Program Applications & Supplementary COVID-19 Health and Safety Plan Materials

DPH PHL sends requirements of the emergency order or Applicant downloads application packet to complete
DPH PHL receives application and supplementary materials via email
DPH PHL reviews general overview of PHL aspects of application and State required supplementary materials
DPH PHL sends application to CERT at HealthPlan@SFCITYATTY.org , if approved by DPH PHL.

 Applications should include times/locations of events. CERT, or Community Emergency Response Team, may conduct periodic spot checks to ensure compliance with local regulations.
